COVID-19 vaccination in Estonia – official information from vaktisineeri.ee.

Occupational health room at Tõnismäe unit

- Vaccination with the COMIRNATY (BioNTech Manufacturing GmbH) vaccine in the occupational health room (TP0203) at the [Tõnismäe unit](#).
 - We invite people from the age of 12 to come and get vaccinated, preferably at a time booked through the [e-booking system](#).
 - East Tallinn Central Hospital does not vaccinate children aged 5-11.

Vaccination of immunocompromised patients with extra doses of COVID-19 vaccine

- At a time booked by an East Tallinn Central Hospital specialist doctor or based on a digital referral.

How can you book a time to get vaccinated?

A vaccination appointment can be booked

- through the digital registry
- by calling 1247 (Mon–Fri 8 am to 8 pm)

For more information on vaccination, call the **helpline 666 1900** of East Tallinn Central Hospital. For vaccination-related health issues, contact your GP or consult the general practitioner's **helpline 1220**.

Please note! Make sure your contact information is correct (e.g. phone number and SMS preference) in the ETCH patient portal www.ipatsient.ee in order to receive an SMS notification (if your vaccination is booked at least 2 days ahead). If you have not marked the box asking for SMS permission or your phone number is incorrect, the message will not reach you.

Before booking an appointment, please note that the second dose is administered after a specific interval (e.g. the second dose of Pfizer/BioNTech is given after six weeks). For example, if you receive the first dose of the vaccine on 24 May, the second dose will be given on 5 July. Please make sure you are available for your second dose appointment.

Things to consider before your COVID-19 vaccination

- You must have valid identification with you when coming for your vaccination.
 - The entire vaccination process will take up to 30 minutes (arrival, registration, vaccination and 15 minutes in the monitoring area).
 - Only come for your vaccination if you are healthy. Wear a mask.
 - When you come for your vaccination, wear clothes that allow you to comfortably expose your shoulder for the injection. COVID-19 vaccines are administered into the upper arm.

What if you can't make it to your vaccination?

It is important for people who have booked an appointment to make sure they come for their vaccination. If for some reason you cannot come, please cancel your appointment immediately through the eBooking System or the patient portal iPatsient or by calling [666 1900](#) (Mon-Fri 07:15-18:00).

When will you receive your second dose?

You will be informed of the time of your second dose while you are registering for your first one.

Before booking an appointment, please note that the second dose is administered after a specific interval (e.g. the second dose of Pfizer/BioNTech is given after six weeks). For example, if you receive the first dose of the vaccine on 24 May, the second dose will be given on 5 July. **Please make sure you are available for your second dose appointment.**

Booster dose

In Estonia, you can get a booster dose from age 18. All adults need to get a booster dose, but it is most critical for at-risk groups, where weakened immunity can lead to severe disease. A booster dose reduces the [risk of infection](#) as well as the likelihood of becoming seriously ill several times.

You are eligible for a booster dose if your primary vaccination course was:

- at least three months ago for COMIRNATY, SPIKEVAX and VAXZEVRIA (AstraZeneca AB) vaccines

- at least two months ago for COVID-19 VACCINE JANSSEN

According to the expert committee on immunoprophylaxis, those who have contracted and recovered from the coronavirus [should](#) get a booster dose five months after their first dose.

Maximum protection from the booster dose will develop within two weeks after the injection.

Will I be issued an immunisation passport?

Information about your vaccination will be entered in the health information system where you can see it yourself from your electronic health record and print out the e-immunisation passport if necessary. If you wish, you can also have the information entered in your paper immunisation passport. We do not issue new immunisation passports on site.

What to do when I do not have possibility to create the certificates at the Patient Portal?

[The service centres of the Social Insurance Board](#) are accepting applications for creating EU COVID certificates by Estonians and foreigners who have been issued the Estonian ID-Code, who do not have the possibility to create the certificates by themselves at the Patient Portal (digilugu.ee).

EU COVID certificates which involve proof of vaccination, proof of a negative coronavirus test result or proof of having had COVID-19, shall be issued [in the service centres of the Social Insurance Board](#).

The foreigners who turn to the Social Insurance Board for getting a COVID certificate, must present their Estonian ID-code and a document of identification. [The application form](#) may be prefilled and printed. Please take the application to the service centre of your convenience. The EU COVID certificate will be sent to the e-mail of the applicant within three working days. The service is free for everyone.
